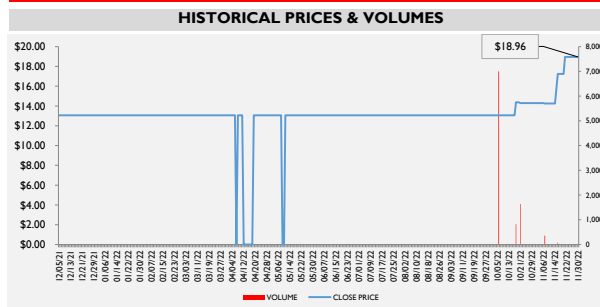

SCI has declared an interim dividend of US\$0.00262 per share payable on October 14, 2022 to all shareholders on record as at September 30, 2022. The ex-dividend date will be September 29, 2022.
2-Sep-22	Ordinary shareholders who hold J\$ shares will be paid the J\$ equivalent of the US\$ dividend declared per share. The exchange rate used will be the weighted average spot selling exchange rate published by the Bank of Jamaica (BOJ) five (5) business days immediately preceding the date of payment of the dividend. SCI has submitted its audited financial statements for the year ended June 30, 2022.
